

TERMS & CONDITIONS

A. General

1. This "**Beyond The Limits Contest**" (hereby known as "Contest") is organised by Mitsubishi Motors Malaysia Sdn Bhd (hereby known as "the Organiser").
2. The Contest is subject to the terms and conditions stated herein and the Organiser reserves the right to vary, add, modify and/or alter these terms and conditions as and when it deems fit. Such variations may be communicated through modes of communication deemed suitable by the Organiser.
3. By participating in the Contest, the participant declares that he/she has read and understood the terms and conditions herein and agrees to be bound by the same.

B. Eligibility

The Contest is open to:

1. All individuals aged 18 and above,
2. Are Malaysians holding a valid MyKad; or
3. Foreigners residing and working in Malaysia with a valid working pass

C. Contest Mechanics – How to Participate

Participants are required to:

2. Record a testimonial video between the duration of 1-2 minutes based on the weekly themes given.

D. Determination of Winners

4. The Organiser shall have the sole and absolute discretion to disqualify any inappropriate submission(s) and/or any submission(s), which fails to comply with the Terms and Conditions, stated herein.

E. Contest Period

1. This Contest will commence on 02 November 2020 and ends on 29 November 2020 ("Contest Period"). Any entries received after the respective Contest Period will be automatically disqualified.
2. The Winners will be announced weekly via Mitsubishi Motors Malaysia's Facebook page after the Contest ends.
3. Participants are advised to check for any updates pertaining to the Contest on Mitsubishi Motors Malaysia Facebook, from time to time, during the Contest Period.

F. Prizes

1. The prizes for each winner is as of following:
 - a. Grand Prize: RM1,000 shopping voucher each winner
 - b. Consolation Prize: RM200 shopping voucher each winner
2. If the selected winner is an existing Mitsubishi Motors Malaysia owner, additional Service voucher will be given such as the following:

 - b. Consolation Prize: Additional RM200 Service Voucher each winner
3. The Prizes collection mechanism for the Contest are as follows:

 7. The Organiser reserves the right to use any other mode or medium that it deems fit at its sole and absolute discretion for the purpose of announcing the Winner, contacting the Winner, verifying the identity of the Winner.
 8. The Prize is accepted entirely at the risk of the Winner and the Organiser excludes itself from any express or implied warranties in connection with the Prize to the extent permitted by law.
 9. The Prize is not exchangeable or redeemable for cash or any other item and cannot be resold or offered for resale. Unless otherwise approved by the Organiser in writing, the Prize is not transferable. If the Winner chooses not to accept the Prize for any reason, there will be no compensation offered.
 10. However, the Organiser may at any time at its sole and absolute discretion substitute the Prize with other items of an equal or similar value with or without conditions.

G. Other Terms and Conditions

For the purposes of section G herein, "participant" or "participants" shall also include the Winner.

1. The Organiser may at its sole and absolute discretion disqualify any participant and/or revoke the Prize at any time, where:
 - a. The participant fails to comply with the terms and conditions stated herein;
 - b. The participant attempts to undermine the operation and administration of the Contest by fraud, cheating or deception;
 - c. The participant fails to provide accurate, complete, valid, identifiable and/or truthful information during participation, registration to participate and/or at any stage of this Contest.
2. The participant shall not engage in any conduct that directly or indirectly brings the Organiser or the persons managing the Contest in a state of disrepute.

3. The user of 'aliases' shall be considered as a form of deception and is prohibited.
4. In the event that the Contest is cancelled, postponed and/or abandoned for any reason, the Organiser without being subject to any form of liability and at its sole and absolute discretion may or may not choose to substitute the prize with other item(s) of an equal or similar value with or without conditions. In such an event, the Organiser shall not be liable and/or responsible in any manner whatsoever for any form of claim and/or liabilities howsoever arising whether direct, indirect or otherwise.

By the participant submitting his/her personal data to MMM for this Contest, the participant hereby consents to MMM processing his/her personal data according to the PDP Notice.

By participating in this Contest, the participants hereby consent to MMM to use, publish, exhibit and display participant's name, the last four digits of their Identification Card Number, image and comments in any nature or form for documentation, advertising and promotional purpose in any form of media and any reasonable manner it sees fit without additional compensation. The participants are not eligible to claim any proprietary right thereto.

The Organiser may at its sole and absolute discretion prohibit participation by any participant and/or Winner who in any manner whatsoever disrupts, tampers and/or engages in improper conduct that affects the Contest and/or the administration of the Contest and/or breaches any of the terms and conditions stipulated herein.
